INTRODUCTION

CMR University Legal Services Clinic intends to provide legal services to the socially and the economically backward sections of the society who have difficulty in accessing the judicial system. Legal service clinic provides legal services to the people. The thrust is on the basic legal services to achieve Social, Economic and Political Justice that are enshrined in the Preamble of the Constitution of India and under the Directive Principles of State Policy. The legal services clinic is a great opportunity to understand the difficulties faced by people in distant villages lacking access to justice and to deliver to them the much-needed access to justice.

National Legal Services Authority (Legal Services Clinics in Universities, Law Colleges and other Institutions) Scheme, 2016 and Bar Council of India mandated all law colleges and universities in India to establish and run legal services centres or clinics as a step towards ensuring effective access to justice. Section 4(k) of the Legal Services Authorities Act, 1987 mandates the National Legal Services Authority to develop, in consultation with the Bar Council of India, programs for clinical legal education and promote guidance and supervise the establishment and working of legal services clinics in universities, law colleges and other institutions.

Through this the students can gain professional as well as practical knowledge through the programs. Regardless of the path they choose, the students will gain practical skill while bringing life-changing legal services and by spreading more legal awareness. Students develop skills such as leadership, problem solving and social management which are otherwise difficult to acquire. This knowledge and experience will be empower them in making social changes for the benefit of the community at large.

With this CMRU Legal Services Clinic aspires to guarantee equal access to justice for all by opening a village level legal services clinic in Munuganahalli and Kuruburu gram panchayat at Chintamani Taluk.

Sri. Shashidhara Shetty conducted a session on the Legal Services Authorities Act of 1987 and discussed the Legal Services Camp Module with the students who were going to embark on a village level camp to conduct a door-to-door survey. He explained the constitutional provision of Article 39A which provides that State shall secure that the operation of the legal system promotes justice on a basis of equal opportunity, and shall in particular, provide free legal aid, by suitable legislation or schemes or in any other way, to ensure that opportunities for securing justice are not denied to any citizen by reason of economic or other disability. Articles 14 and 22(1) also make it obligatory for the State to ensure equality before law and a legal system which promotes justice on a basis of equal opportunity to all.

- A. Section 12 of the Legal Services Authorities Act, 1987 prescribes the criteria for giving legal services to the eligible persons. Section 12 of the Act reads as under:-
- Every person who has to file or defend a case shall be entitled to legal services under this Act if that person is -
- (a) a member of a Scheduled Caste or Scheduled Tribe;
 - (b) a victim of trafficking in human beings or begar as referred to in Article 23 of the Constitution;
 - (c) a woman or a child;
 - (d) a mentally ill or otherwise disabled person;
 - (e) a person under circumstances of undeserved want such as being a victim of a mass disaster, ethnic violence, caste atrocity, flood, drought, earthquake or industrial disaster; or
 - (f) an industrial workman; or
 - (g) in custody, including custody in a protective home within the meaning of clause (g) of section 2 of the Immoral Traffic (Prevention) Act, 1956 (104 of 1956); or in a juvenile home within the meaning of clause.
 - (j) of section 2 of the Juvenile Justice Act, 1986 (53 of 1986) or in a psychiatric hospital or psychiatric nursing home within the meaning of clause (g) of section 2 of the Mental Health Act, 1987 (14 of 1987); or
 - (h) in receipt of annual income less than rupees nine thousand or such other higher amount as may be prescribed by the State Govt., if the case is before a court other than the Supreme Court, and less than rupees twelve thousand or such other higher amount as may be prescribed by the Central Govt., if the case is before the Supreme Court." (Rules have already been amended to enhance this income ceiling).

This was followed by a session on the status, importance and relevance of Legal Services Clinics in law colleges by Sri Vignesh Kumar, Public Relations Officer, KSLSA.

National Legal Services Authority (Legal Services Clinic) 2016:

Legal Aid Clinics are intended to provide legal relief easily accessible to the indigent and backward sections of our society. They are almost on the lines

of primary health centres where a doctor and other auxiliary medical staff provide basic health care to the people situated in village areas affected with poverty and social squalor. Like the doctors rendering health services to the people of the locality in the primary health centre, a lawyer manning the legal aid clinic provides legal services to the people. The thrust is on the basic legal services like legal advice and assisting in drafting of notices, replies, applications, petitions etc. The lawyer manning the legal aid clinic will also attempt to resolve the disputes of the people in the locality, preventing the disputes from maturing into litigation. This provides the lawyer in the legal aid clinic an opportunity to understand the difficulties faced by people in the distant villages' for access to justice. Legal aid clinics have to be manned by para-legal volunteers selected by the Legal Services Authorities and lawyers with a sense of commitment, sensibility and sensitiveness to the problems of common people.

These provisions shall mutatis mutandis be applicable to the student' legal aid clinics set up by the law colleges and law universities also. The students legal aid clinic shall always be under the supervision of a faculty member who shall be present in such clinics for immediate consultation. Law students of the law colleges / law universities may be engaged to adopt a village especially in the remote areas and organise legal aid camps. The students in the legal aid clinics may seek the assistance of the para-legal volunteers in the legal aid clinics. The Student legal aid clinics may conduct surveys and prepare reports. The student legal aid clinics working in the remote villages may conduct surveys of the legal services required for the people of that area including identification of the problems which call for a social justice litigation. For conducting4 surveys, members of the student legal aid clinic may seek the assistance of the para-legal volunteers and

voluntary social welfare institutions working at the grass-root level. The student legal aid clinics shall send reports to the State Legal Services Authorities with copies to the legal services institutions having territorial jurisdiction and also to the District Legal Services Authorities concerned.

LEGAL AID *VISA VIS* CONSTITUTION OF INDIA

LEGAL SERVICES AUTHORITIES ACT 1987

- An Act to constitute legal services authorities
- to provide free and competent legal services to the weaker sections of the society
- to ensure that opportunities for securing justice are not denied to any citizen by reason of economic or other disabilities, and
- to organize Lok Adalats to secure that the operation of the legal system promotes justice on a basis of equal opportunity.

CONSTITUTIONAL BASIS

- Article 39A of the Constitution of India provides that
- State shall secure that the operation of the legal system promotes justice
- on a basis of equal opportunity, and
- shall in particular, provide free legal aid, by suitable legislation or schemes or in any other way,
- to ensure that opportunities for securing justice are not denied to any citizen by reason of economic or other disability.



LEGAL AID *VISA VIS* CONSTITUTION OF INDIA

LEGAL AID

- Legal Aid implies giving free legal services to the poor and needy who cannot afford the services of a lawyer for the conduct of a case or a legal proceeding in any court, tribunal or before an authority and includes giving of advice on any legal matter.

CONSTITUTIONAL BASIS

- The Preamble of our Indian Constitution secures to all its citizens; **JUSTICE**, social, economic and political and **EQUALITY** of status and of opportunity.
- Articles 14 and 22(1) also make it obligatory for the State to ensure equality before law and a legal system which promotes justice on a basis of equal opportunity to all.

The students with the knowledge and taking their learning from the first day started their second day with much more enthusiasm as the second day programme was entirely based on the information that would be of help during the village visit to Munuganahalli and Kuruburu Gram Panchayats.

Day 2 mainly focused on educating and inspiring law students to be service oriented and to train them to handle legal services camps. The speakers of the day shared their experiences as public office holders which in sighted the students to the challenges of reaching the rural population and how the authorities can meet the same. The training focused on specific legislation the Protection of Women from Domestic Violence Act, 2003, Protection of Children from Sexual Offences Act 2012, The Juvenile Justice (Care and protection of Children) Act, 2015, Child Labour Act, Right to Children to Free and Compulsory Education Act 2009, Right to Information Act, 2005, Intellectual Property Right, the Information Technology Act, 2000, The Maintenance and Welfare of Parents and Seniors Citizens Act, 2007.

The students got to know the SOP (Standard Operating Policy) that any college should follow during the village visits. The SOP was explained in detail by Naveen. Thereafter, Advocate Vidya Selvamony enlightened students with a wonderful understanding of the Protection of women from Domestic Violence Act, 2005 along with Protection of Children from sexual Offences Act, 2012. This session by Advocate Vidya was an intricate one which would help the students to answer the questions and enlighten the villagers during their village visit to Chintamani Taluk. Followed by a session of the Juvenile Justice (Care and Protection of Children) Act, 2015 was conducted by Ms. Kanchana Devi T. Assistant Professor. The session was a

detailed one which made the students of CMRU SOLS understand the act and the reasonable behind the formation of the act in 2015.

Next was the cultural shows which would be displayed in the villages through which the villagers of all groups would be made aware about four major topics which includes women empowerment, prohibition of child labour and child marriage, prohibition of corruption and traffic rules and road safety through the means of dance and street plays. The theme for the village visit was women empowerment led by Muskan, Swetha and Vinod (students of CMRU SOLS). They performed the theme through a performance of dance which included around twenty students which has given a clear understanding of the cruel activities that are prevalent in the society on women along with what should not be done and what are the laws that are available to women from the government. The topic of prohibition of child labour and child marriage was led by Vibha and a team of eight students through skit depicting the understanding of forbiddance of child labour and child marriage along with the educational rights available to all children freely. The next topic of prohibition of corruption was led by Chandana, student of CMRU SOLS which explained in detail through role play the problem of corruption in the society which majorly focused on the corruption that goes on in the revenue department and the ways to curb such social evil. The awareness of road safety and traffic rules was created through street play led by Preethi and a team consisting of eight (students of CMRU SOLS) to bring awareness about the basic traffic rules that has to be followed such as driving with DL, insurance, helmet.

After the cultural shows, was the session conducted by Ms. Ramya R, Assistant Professor has put forward a detailed insight to the Right of Children to Free and Compulsory Education Act, 2009 and Right to Information Act, 2005. The team of Intellectual Property Rights and Cyber

Crime took over the session post lunch which was led by Ms. Vidya MN, Assistant Professor and the LLM students of CMR. As both the topics being the need of the hour, it helped the students highly as it gave them a detailed understanding of the topics which helped to answer the questions regarding these topics during the village visit. The next session was conducted by Prof. (Dr.) V J Praneshwaran, Director CMR School of Legal Studies, has given a detailed insight to the Maintenance and Welfare of Parents and Senior Citizens Act, 2007 which is one of the contemporary topics which has to be looked into with utmost seriousness. Post this session, the Director gave the code of conduct for students that have to be followed during the village visit.

The next session was the one of the important sessions of the day which was led by the student co-ordinators of the legal visit team. It was initiated by Bhaskar, student of final year CMRU SOLS who explained the methods of data collection from the field and the procedure for the same. The dos and the don'ts of the village visit was shared by Syed Bakhar Azeez and Surya S, students of CMRU SOLS gave a detailed vision to the questionnaire that would be used during the village visit to collect the data from the villagers. The field visit rules, travel details were given by students of third year. After which the entire batch of eighty three students that were visiting the village were divided into teams of eight consisting ten students in each team including a team co-ordinator. Each team was given respective villages that they would have to go to for the data collection in the respective villages of Munuganahalli and Kuruburu Gram Panchayats. Along with this, the students were also given the roles and responsibilities that they would have to carry during the entire time of village visit. The part of this session was taken over by Sharath, final year student CMRU SOLS who explained the plan of action.

The students who visited the village by the end of two-day programme got an overview and a clear understanding of how the village visit would be and how exactly things would work along with getting to know the experience that they would get during the six days of village visit to Munuganahalli and Kuruburu Gram Panchayat in Chinatamani Taluk.

18th May 2022 – Training provided to students with regard to village visit





18.05.2022 (Meeting with District Level Authorities)

The student coordinators namely Syed Bakhar Azeez, Bhaskar B. S., Sharath S., Sainadh Reddy and Gagan M. R. along with faculty coordinator Adv. Vidya Selvamony had visited the District Level authorities with regard to village visit. The authorities present during the meet were PDJ, Sri. Lakshmikanth

Janakiram Miskin, Member Secretary, District Legal Services Authority, Justice BS Naik, Principal District and Sessions Judge, Chikkabalapura, district level officers of 18 departments and also Mr. Arsalan, IFS, deputy conservator of forests, Chikkaballapura division and the Deputy and Asst Directors of 18 departments were present in the meeting.

The students presented the plan of action which they would be initiating in the village for providing legal help to the people at the said village. Faculty coordinator Adv. Vidya Selvamony gave a brief speech on the activities conducted by the legal services clinic. The PDJ gave instructions to the authorities present in the meeting to install stalls on 27th and 28th May 2022.

19.05.2022 (Spot Inspection for the theme programmes at Munuganahalli)

The student coordinators namely Bhaskar B. S., Sainadh Reddy and Shivakumar had conducted a spot inspection in each place at Munuganahalli wherein they planned accordingly the location which will be used to perform each activity during the tenure of village visit.

20.05.2022 (Final Meeting and invitations with the respective authorities)

The student coordinators along with the faculty coordinator had their final meeting before starting with the village visit. The student coordinators took a great initiative by dividing their work and inviting the respective authorities for the program and support the students during the legal service.

Student coordinators Tejashri Inder and Shreya Shrivastava had made their visit to the Karnataka Legal Services Authority and had invited Sri Shashidhara Shetty, Member Secretary KSLSA, Sri Vignesh Kumar, Public Relations Officer, KSLSA and Smt. Kaveri, Deputy Secretary, KSLSA to

support the students on 27th and 28th May 2022. Member secretary KSLSA and PRO KSLSA had given instructions which the students must follow during the visit at Chintamani Taluk. The Karnataka Legal Services Authority also supported the students by providing them a few audio clippings which they can use to spread awareness at the village. A few pamphlets were also shared with the students.

We had meeting with Taluk Level Officers. Sri. Lakshmikanth Janakiram Miskin, Member Secretary, District Legal Services Authority presided the meeting and instructed the officials to install stalls and coordinate with the students at ground level. PROCEDURE FOLLOWED DURING THE VISIT BY THE STUDENTS

The students were accompanied on all the five days along with their faculty coordinators and faculties of the universities who supported the students throughout their journey in completion of their task successfully.

A team of 83 students from SOLS assisted the clinic with regard to the survey. The survey was conducted for a period of 6 days. A team of 6 students was allotted in every village for the survey. The survey team conducted a door-to-door basis survey in all the villages of this Panchayat. The survey was conducted for a period of 3 to 4 days and the collected data of the survey will be reported to the District Legal Services Authority.



Meanwhile, another team of 6 students i.e., cultural team of CMR University School of Legal Studies Legal Aid Clinic visited the villages and the Government schools within the limits of the same panchayat. The students of

our university assisted the students of the government school with basic legal knowledge with respect to child rights and environmental laws by means of skit, singing, and some competitions. The cultural team will also perform street role plays in every village which will provide legal awareness among the villagers at the said villages.

We had complete support and cooperation from Karnataka State Legal Services Authority, District Legal Services Authority, District and taluk administration and panchayat representatives.

These 5 days we organised theme based programmes. such as women rights and empowerment, Agricultura, farming, fishing and sericulture, Environment protection, wild life protection and plantation of trees, Cyber Crimes, Intellectual Property Rights, Information Technology Act.
